Membership Agreement

Trucks For Change Network Inc. (the "Company") is a not-for-profit Ontario corporation which provides information and administrative services which facilitate the matching of service requests from charitable organizations with offers of services from its member trucking and logistics firms (the "Members").

The undersigned (the "Client") acknowledges and agrees with the following terms and conditions of using the corporate matching services of the Company:

- (a) To pay to the Company a fee of sixty dollars (\$60.00) for each offer of a Member's service which is accepted by the Client and which results from the Company's services.
(b) That the Company is not authorized to act on behalf of the Client.
(c) That the Client is under no legal obligation to accept any offer of a Member's service resulting from the Company's services.
(d) That the actual trucking and logistics services to be performed will be evidenced and be enforceable by and under separate agreements, invoices, or other instruments (the "Service Contracts") made directly between the Members and the Client.
(e) That the Company will not be held directly or indirectly liable, and will be indemnified and held harmless by the Client for all losses, damages, costs or other liabilities related to or arising from the Service Contracts.
(f) To use reasonable commercial efforts to keep confidential all proprietary and confidential information received through the Company regarding its Members, their service rates, and their business affairs.
(g) To assist the Company in developing information which recognizes the Company and its Members for the financial value of donated and discounted services accepted by the Client, all such programs to be in compliance with Canada Revenue Agency regulations governing charitable donations.
(h) This agreement will remain in full effect unless and until terminated by either party by providing written notice to the other party.
